Today she is quiet, withdrawn and seems to avoid eye contact. You have noticed this seems to happen after the weekends when she is staying with her mother and step father but not during the times she lives with her father and his partner. When you try and talk to her she pulls away when you touch her and is clearly in pain. She says she fell over but even though it is hot day she refuses take off her long sleeved jumper. She offers little reaction to you attempts at trying to talk with her although she will often chat with other fathers when are collecting their children. You notice too that she is quite startled when another child cries and is quite nervous, hyperactive, aggressive and disruptive.

What would you do in this situation? Who would you discuss this with? How would you decide if you thought Lucy may have been abused? What would you do if you were concerned for her safety?
