### What is it?

Open Surgeries are opportunities for participants to consult with editors of journals and book series in open, flexible and distance education to explore avenues for getting their conference papers published in their journals and books.

## How will it operate?

These surgeries will operate as "walk-in clinics" over lunch times as well as during parallel sessions throughout the duration of the conference. At these consultation sessions conference participants will be able to examine samples of various publications in the field, pick up information on them and make an appointment to talk to any one of the editors on how they might get their work published in these outlets.

#### What will be covered?

Topics covered at these walk-in clinics could range from anything to do with the nature, scope and coverage of different publications, the opportunities and limitations of their publication styles, formats and conventions (namely open access etc.) and how these can be meaningfully addressed without affecting high quality and standards of publishing.

## **Expected outcomes?**

A tangible outcome of these consultations would be progress towards the identification of papers that are linked to development goals and preliminary discussions on how these could be developed for publication in journals and book chapters in the field.

Editors of the various journals in the field will be available onsite to help interested authors think through this process, including setting goals and targets, and a plan for achieving them.
